#### **Background**

In September 2019, the president of the European Commission, Ursula von der Leyen, named the European Green Deal as "Europe's hallmark". This ambitious 250 billion Euro project aims at no less than "becoming Europe the first climate-neutral continent" – putting decarbonisation at the core of this concept.

Whilst focusing mainly on internal regulations and economic incentives for the EU member states, its impact on the external relations is still unclear. If this programme is successful, it will not only support and strengthen the role of the European Union as a normative power. It will also reinforce the *EU's* position as a global leader in other fields such as circular economy and green technological innovation.

Decarbonisation can only be achieved if other major economies join in this transformation. The geopolitical implications of the Russian war in Ukraine now pose additional challenges to this agenda. The nations of the Asia-Pacific region are key as they will remain the most dynamic ones and are currently undergoing their own major transformations.

Against this background, Konrad-Adenauer-Stiftung has commissioned a study by Professor Dr. Sonia Chikh M'hamed, ESCCA Shanghai/Angers, on The European Green New Deal: Perspectives for the EU-Asia relationship. During this webinar major findings will be presented and discussed within the wider framework of decarbonisation with European and Asian experts.
