



A plan of actions for 2011-2014

The axes of actions

- Angers setting an example

Eg : public purchases, teleworking, energy management of buildings and public lighting, mobility, habitat, ...

- Raising awareness, mobilisation of participants and animation of the territory.

Eg : actions aimed at a young audience, agents, residents, one single booth for participants, ...

- Action to reduce emissions

Eg : Support for a changing economy (building professionals, circular economy, ...), eco-conditionality, ...



2015/2016 : greenhouse gas assessment, evaluation and reflection on the 2nd plan of action


THE BIODIVERSITY AGENDA 21

An actions plan for 2014-2020



The axes of action

- Knowledge of the territory and of its biodiversity.
E.g. : inventories, participative science and highlights, ...
- Development of services which biodiversity brings
E.g. : discovery itineraries, urban agriculture, ...
- Integration of biodiversity in development projects
E.g. : green and blue framework, 0 pesticides
- Taking into account of the biodiversity in the animal and vegetable production industries, research
E.g. : training, plant selection and new varieties, ...



62 actions

Examples of Actions

Climate Energy

The Biscottes Recycling centre

A welfare-to-work programme to collect reusable waste, put it to good use and to resell it in shops.

Objectives:

- Creation of Jobs
- Reduce of the volume of waste put into landfills
- Allow people in difficulty to obtain materials at a low price



2 000 / 2 500 visitors
each week

369 tons of waste
collected in 2015 : 29% of
which has been reused



- 3 Angers Loire Borough collection points reserved by agreement: 50 to 60% of the tonnage collected
- Pro Recycling Centre aimed at businesses, local authorities and associations
- Partnerships : artists and creative people, tool hire bank, exchanges of practices and visits.


Biodiversity

The 'zero pesticides' actions programme

A programme of actions to facilitate the application of future legal obligations

Objectives

- Support the territory's communities
- Facilitate and reinforce new practices
- Raise awareness to individuals
- 3 workshops envisaged for 2016



1st workshop : 35 participants and 16 boroughs represented



- Agents of the communities : 2 exchange workshops and a training session in recognition of wild flowers and weeds
- Residents : display and explanatory flyer campaign, 'herbs in the city' exhibition

EXAMPLES OF ACTIONS

Culture – citizenship

The Citizen Day

A day of mobilising residents in favour of collective and interdependent operations

Objectives

- Get people from Angers involved in citizen actions
- Improve the framework of life and the environment of people from Angers by engaging the latter for one day



- 450 participants in 2015.....650 in 2016
- Actions in the whole of the town : repair café, participation in counting collections at the Fine Arts Museum, raising awareness about food waste, picking up of litter on the banks of the river Maine,


The managerial plan to fight against discrimination and for equality

A positioning and joint work plan in the City of Angers, the CCAS and the Angers Loire Borough


Objectives

- Inform and fight against all forms of discrimination, guarantee equality in the authority
- Develop a collective and interdisciplinary approach

Angers Loire Borough : division by age group in 2015



Angers Loire Borough : men / women division in 2015



- 6 work groups put into place in 2013
- 14 actions in progress out of 32 : decasualisation of agents, accessibility, professional routes, conciliation of professional and personal time, ...
- Authorities created : follow-up committee, consultative group, watchdog and referring agent

Perspectives and Reflections

Sustainable development report

- Integration of actions of the boroughs and other partners (local dynamic)
- Joint report to the 2 authorities (readability)
- Link with the objectives of the 2016-2030 territory project and work on indicators

Climate Energy

- 2nd plan of actions : reflection on the perimeter and the internal process
- New actions : diagram with guide of the heat networks, unity of purification of biogas issued from the treatment of the sludge of waste water, ...

Biodiversity

- Local dynamic with the boroughs (floristic assessment of the territory, exchange workshops, ...)
- Continuing of the implementation of a plan of actions.
